General	1. Helijet tickets held by the Ticket Stock Holder will be kept in a secure location. 2. The Ticket Stock Holder accepts responsibility for the use of the Helijet Tickets received. 3. In the event of Helijet Ticket Stock being stolen or lost, the Ticket Stock Holder accepts liability until such time as the Ticket Stock Holder notifies Helijet of the missing ticket(s). 4. The Ticket Stock Holder agrees that no commissions, charges, or other fees are applicable. 5. The Ticket Stock Holder will issue Helijet Tickets in the ticket number sequence. 6. The fare used to invoice the Ticket Stock Holder for tickets will be the full fare applicable on the flight as stated when making the reservation, with the exception of Pre-paid Quick Tickets. 7. Tariff rates are subject to change without notice.
Bill on Use Quick Tickets	8. The Ticket Stock Holder will be invoiced twice a month for all used tickets issued to the Ticket Stock Holder's Account. Payment is due and payable immediately. 9. The Ticket Stock Holder <u>must provide a valid Credit Card #, including expiry date and name of cardholder (please fill out attached form) to which Helijet will charge, on billing day, for the amount outstanding.</u> Helijet reserves the right to refuse re-issuance of Quick Tickets.
Pre-Paid Quick Tickets	10. Order for Pre-paid Quick Tickets must be accompanied by a Company Cheque or complete Credit Card information to cover the full amount agreed upon. NOTE: Non-refundable & only valid for one year from date of issue.
Termination	11. This Agreement may be terminated at any time by either party upon 30 days notice, at which time, Ticket Stock held by the Ticket Stock Holder will be returned to Helijet. Any tickets not returned will remain the responsibility of the Ticket Stock Holder.
